Serving The Residents of The Town of Oyster Bay

The Town Board is the legislative body of the Town of Oyster Bay. The Board, which includes the Supervisor and six Council members, has the final responsibility for all matters pertaining to the operation of the Town, exclusive of incorporated villages. It exercises this authority in the form of local laws, ordinances and resolutions.

The Supervisor is the chief elected officer and treasurer of the Town. As head of the administrative branch of Town government, the Supervisor is responsible for implementing, executing and enforcing all legislative actions of the Town Board and for the preparation, evaluation and recommendation of reports, information and material for Town Board action. The management of all departments and agencies is subject to his direction, and he is the legal representative and chief spokesperson for the Town.

The Town Board conducts regularly scheduled public meetings on matters relating to zoning, budget and public safety. Its principle duty is to regulate land use within the Town in such a way that it advances the health, safety and welfare of Town residents.
